is in good health, and has not harmed or shown aggressive behavior towards any person or other dog.

PLEASE READ AND INITIAL EACH PROVISION BELOW:

1. ____ I release Club Canine, LLC of any liability arising from my dog's attendance and participation in activities.
2. ____ I fully accept all reasonable risks of illness or injury that may be incurred during normal daycare activity. Such risks include, but are not limited to: cuts, scrapes, and other minor injuries resulting from rough play; and possible contagious illnesses such as upper respiratory infections (of which only one, "bordetella", currently has a vaccination available.)
3. ____ Club Canine agrees to exercise due and reasonable care in the handling of dogs, and in keeping the facility properly enclosed and sanitary. All dogs are cared for by Club Canine staff without liability on Club Canine's part for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons, other dogs, property, or for other unavoidable causes, due care and diligence having been exercised.
4. ____ I understand that I am solely responsible for any harm caused by my dog, while my dog is attending Club Canine, provided reasonable care and precautions are followed by Club Canine's staff.
5. ____ I shall indemnify Club Canine against any claims made against the company, or any losses or damage of any kind suffered by Club Canine as a result of my failure to inform Club Canine of any pre-existing condition my dog may have (including, but not limited to an illness or known aggression problem).
6. ____ I agree to keep my dog on monthly flea treatment (at least April - November) and to take precautions against contagious illness and parasite exposure by consulting with my veterinarian prior to my dog attending Club Canine.
7. ____ I understand that in the event of injury, Club Canine staff may or may not notify me immediately, at their discretion. If the injury is not serious, staff may allow my dog to continue to play, and then notify me when I come to pick up my dog. If the injury is serious, or requires that my dog be removed from group activities, I will be notified immediately.
8. ____ I understand and agree that should my dog become ill or in need of medical attention, Club Canine will first try to contact me. If unable to reach me in an emergency situation, Club Canine staff reserves the right and sole discretion to administer aid, and/or to use any available veterinarians without liability, and I agree to promptly pay for all medical treatments received.
9. ____ I understand that my dog will only be released to the owner(s) on file, unless prior arrangements have been made, in writing, with a Club Canine staff member.
10. ____ I understand that if my dog is left at Club Canine for a period of 3 days past a scheduled pick-up date without contact from me or my authorized representative, my dog will be considered abandoned, and all necessary steps will be taken to turn the dog over to the proper authorities and/or animal rescue agency.
11. ____ I understand that Club Canine closes at 6:30 pm. ONE late pick-up (< 30 minutes) will be forgiven at no charge. After that, a \$5 per 10 minute late fee will be assessed. At 7 pm, Club Canine staff will attempt to contact me, and if I'm still not available, then my dog will be boarded overnight and I will be responsible for all additional boarding fees.
12. ____ I give Club Canine permission to use pictures of my dog(s) on their website or other advertising materials.
